The Eagles' Wings Youth Ranch camping program includes adventure recreation, archery, horsemanship, swimming, campouts, and challenge course. The Challenge Course was constructed according to nationally recognized industry standards and is inspected annually. Certified instructors run it. Every effort is made for the safety and protection of each person from injury. Participation in all challenge course activities is by choice of the participant. In the event of an accident or illness, Eagles' Wings Youth Ranch will make every effort to provide first aid and, if needed, arrange transportation to medical facilities. A camper may be dismissed or not allowed to stay at EW if they bring guns, knives, drugs, alcohol, or any other weapon or harmful substance with them. Camper's bags, jackets, pockets, etc. will be checked upon arrival to insure that we can keep them, staff, and other campers safe in this way. A camper will definitely be dismissed if they act in ways that are harmful to themselves and others or refuse to participate and cooperate in the ranch program.

I am aware that during this person's participation at the Eagles' Wings Youth Ranch challenge course program certain risks and dangers do exist. These include, but are not limited to, the hazards of being in a rural type setting, the forces of nature, other acts of God, and those existing because of the content of the program. In consideration of these activities and environment, I have, and do hereby assume all risks associated with participation in the program and will hold harmless the staff and directors of Eagles' Wings Youth Ranch, from any and all liability, actions, cause of action, debts, claims, and demands of every kind and nature whatsoever, which I now have or which may arise from, or in connection with this person's participation in any activities arranged for him or her by Eagles' Wings Youth Ranch and its staff. The terms hereof shall serve as a RELEASE AND ASSUMPTION OF RISK for heirs, executors, and administrators, and for all members of this person's family.
